

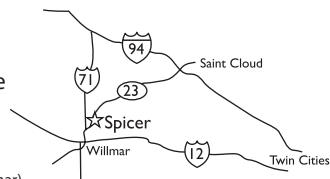
# GREEN LAKE ROAD RACE 2012
